temporary use-on-site residential construction trailer 2023



On-site Residential Construction Trailer Requirements

Pursuant to Section 420-140.1 of the Village Zoning Ordinance

- Allowed on any lot zoned A-2, A-3, R-1, R-2, R-3, R-4, R-4.5, R-5, R-6, R-8, or C-2, District.
 [Note a construction trailer on a commercial development site does not require approval of a temporary use.]
- A construction trailer shall be located on the property which it relates and shall not be used as a temporary dwelling unit.
- The site on which the construction trailer is proposed to be located shall have an active building, zoning or erosion control permit issued by the Village.
- The construction trailer shall meet the following setbacks:
 - ✓ Street setback: minimum of 30 feet from arterial streets or highways and a minimum of 15 feet from nonarterial streets or private roads.
 - ✓ Shore setback: 75 feet minimum.
 - ✓ Wetland setback: 25 feet minimum from the wetlands on the same property.
 - ✓ Side setback: 15 feet minimum.
 - ✓ Rear setback: 15 feet minimum.
 - ✓ Separation between structures: 10 feet minimum.
- The construction trailer shall be located in an area which is accessible for emergency vehicles to the construction trailer and the building under construction.
- The construction trailer shall be comply with all OSHA requirements.
- The construction trailer shall be removed from the property prior to issuance of occupancy for the house or a maximum of two years from the date of the permit was issued for construction of the house, whichever comes first.
- Additional conditions may be imposed to ensure compliance with the provisions of this chapter, its purpose and intent and all other applicable federal, state, county and local requirements.
