



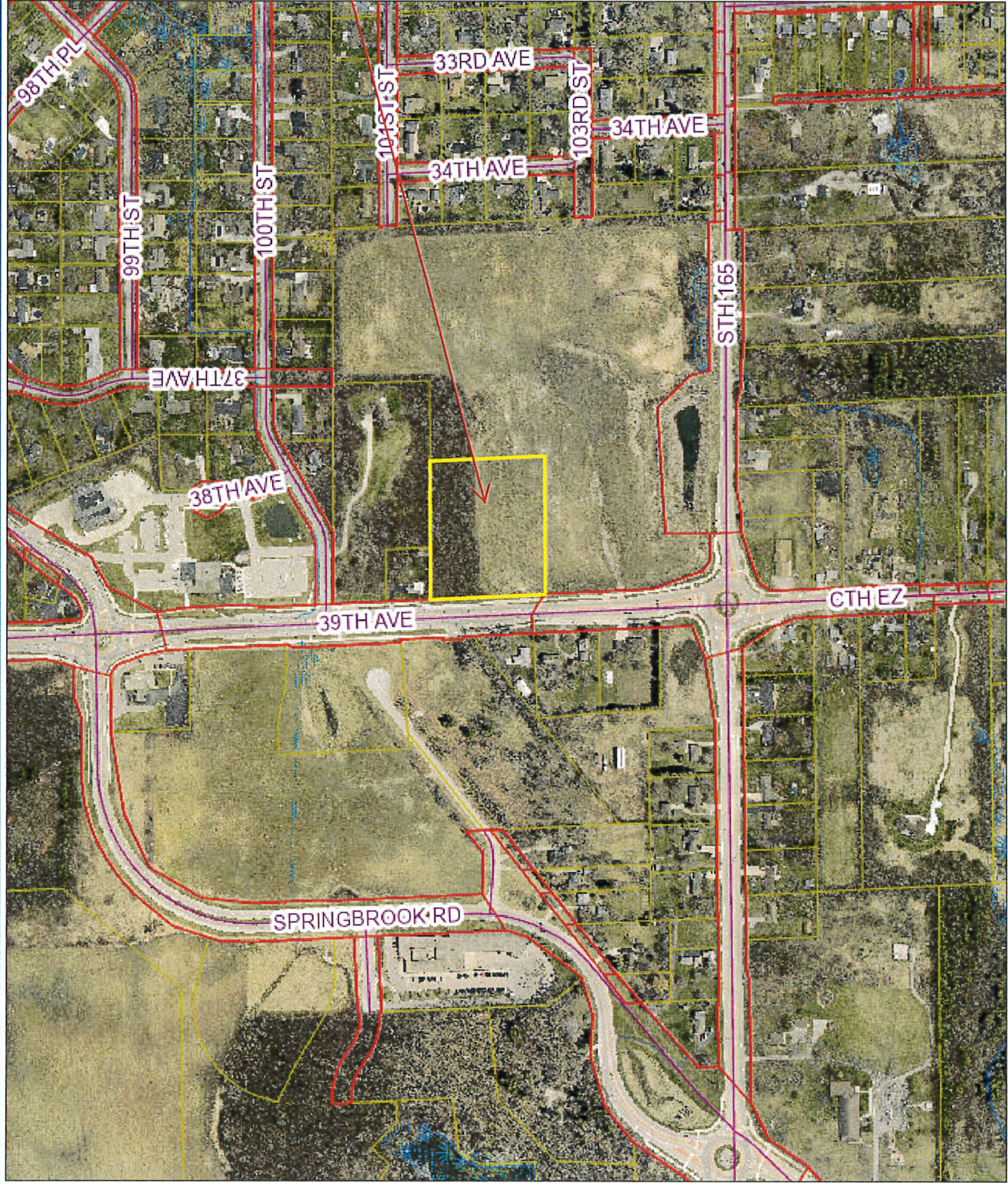
Police Station PUD

Police Station

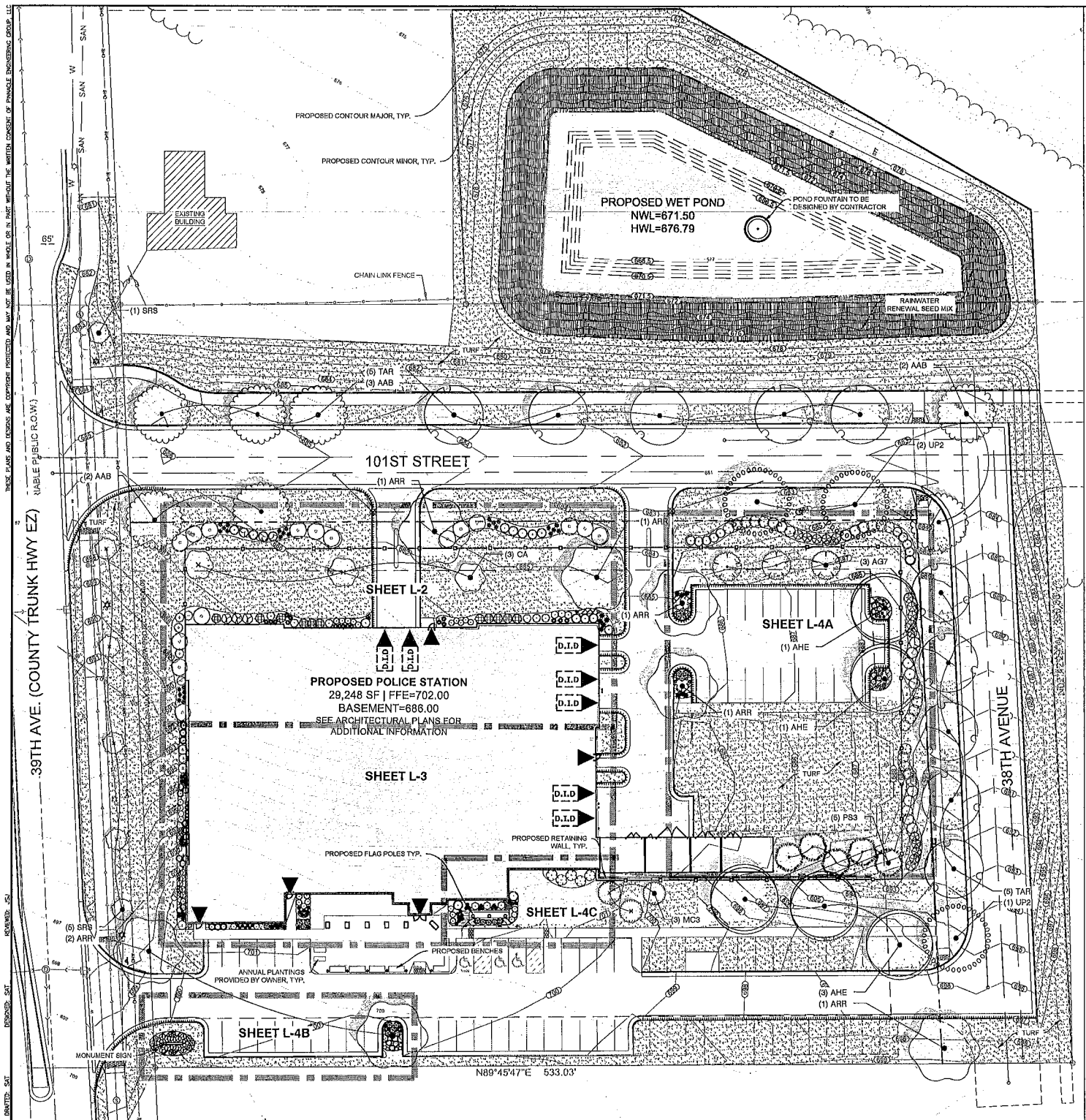

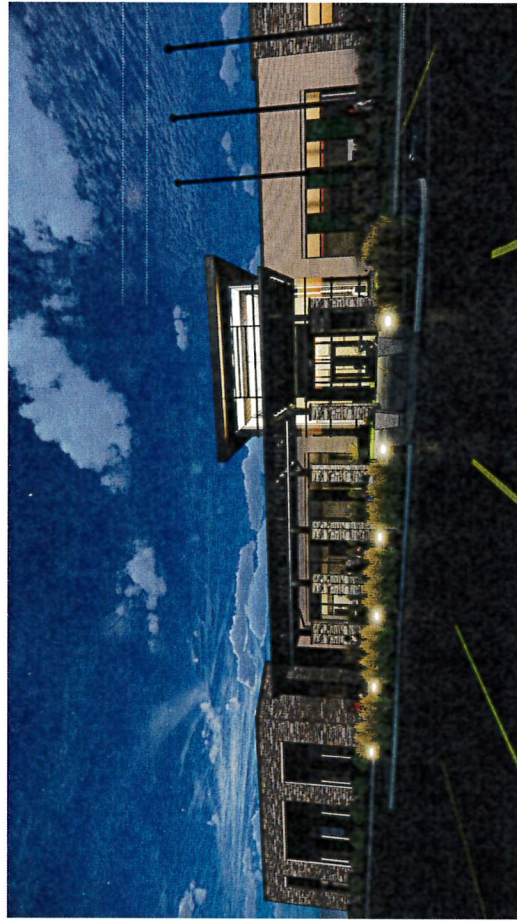

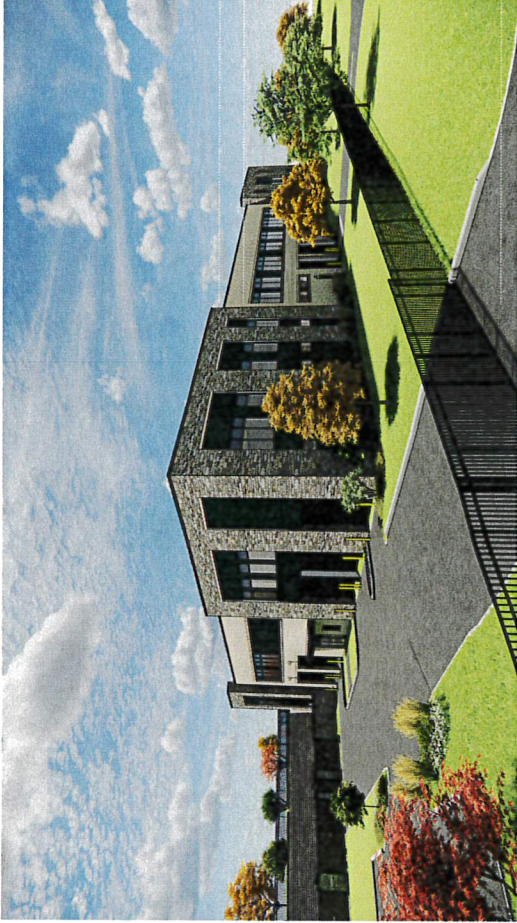
