Commendations Awarded Pleasant Prairie Fire & Rescue

During a Village Board meeting on Monday, August 20, Freodtert South Healthcare presented commendations to members of the Pleasant Prairie Fire & Rescue Department who successfully resuscitated a 67-year-old patient on September 10, 2017, and a 78-year-old patient on June 6, 2018.

On September 10, 2017, a 67-year-old patient was experiencing chest pains and called 911. Upon arrival, EMS members witnessed as the patient became unresponsive. The team quickly initiated both Basic and Advanced Life Support treatments to successfully resuscitate the patient at the scene.

The team of responders continued Life Support treatment as the patient was transferred to Freodtert South Healthcare staff who continued lifesaving efforts. The patient was successfully resuscitated and discharged from the medical center at a later date.

Freodtert South Healthcare presented awards to Lieutenant Adam Craig, Alan Cloherty, Lieutenant Michael Passafaro, Andrew Strouf, and Zachary Keller.

On June 6, 2018, a 78-year-old patient was found unresponsive. 911 Dispatch was able to keep the family calm while EMS members arrived to the scene. Members deployed the new LUCAS chest compression device which mechanically automates CPR and allows the crew to initiate other lifesaving measures as the patient was transferred to Freodtert South Healthcare. The patient was successfully resuscitated and discharged from the medical center after a short hospital stay.

"Pleasant Prairie citizens should be reassured the Pleasant Prairie's EMS team are without question the most advanced, most efficient, and have the highest sound of judgment," stated Dr. Ben Feinzimer, "They are simply the top of the chain of field-based medicine."

The 78-year-old patient was able to attend the meeting and present the awards on behalf of Freodtert South Healthcare to Lieutenant Joseph Olszewski, Asst. Chief David Wilkinson, and firemedics Dean Holloway, Joy Mathein, Parker Jones, and Ronald Weavel.

Stateline 94 Corporate Park

On Monday, August 20, the Village Board considered and approved a Development Agreement between the Village of Pleasant Prairie and Riverview Group, LLC. The company plans to develop approximately 308 acres of property generally located between 110th Street and 122nd Street, and along the east side of the I-94 East Frontage Road (120th Avenue) for the development of five industrial buildings.

In April of 2018, the Village approved the project plan and boundaries for Tax Incremental District #7 for the developer

to fund public infrastructure and roadway improvements, and other utilities for this development. The developer, Venture One, will be responsible for financing several area public improvements and will be reimbursed through tax increment generated by the project. Public improvements along 120th Avenue, 122nd Street and 116th Avenue include street upgrades, sanitary sewer extensions, watermain, street trees, sidewalks, street lights, and sitework. A permanent sanitary sewer lift station will also be installed.

The property is proposed to develop with five buildings to be constructed in 3 phases. Venture One can determine the development phasing order and plans to begin construction during spring of 2019. \Box

Breeze Terrace Moves Forward



During a public meeting on Monday, August 20, Pleasant Prairie Plan Commission considered and sent a favorable recommendation to the Village Board regarding the Comprehension Plan Amendments, Certified Survey Map, Memorandum of Understanding, Zoning Map, and Zoning Text Amendment for the Breeze Terrace Apartments development to be located at the on the east side of 116th Avenue south of Corporate Drive. The Pleasant Prairie Plan commission also approved a Digital Security Imagin System (DSIS) agreement and Access Easement for Breeze Terrace Apartments.

The development includes three-33 unit apartment buildings and six-19 unit apartment buildings with a club house and associated parking and site improvements on 16.75 acres. This will be a gated community. \Box

Fall Residential Leaf Collection

As a part of the Solid Waste Services provided in the Village, crews collect loose, un-bagged leaves directly from your curb or roadside. Four rounds of leaf collection will take place this fall. Weather permitting, leaf collection will run from **Monday**, **October 8 through December 5.** To have your leaves collected, please follow the steps below.


- Identify your collection zone on the map at the right. Then see the schedule to determine your collection dates.
- To prepare your leaves, rake your loose, fallen leaves into a pile at your curb or on your roadside by 7:00 a.m. on your collection dates. Because leaves are collected with a vacuum, they must be piled loose.
- Please keep leaves off of the asphalt.
- Residents with curbs and gutters, place loose leaves on the grass by your curb.
- Residents with a ditch line, place loose leaves on the grass along the roadside of the ditch.
- Leaves must be within six feet of the road.
- Bagged leaves or grass, branches and other yard waste will not be collected.
- Do not mix other yard waste, such as potted/garden plants or branches, into your pile of leaves. Doing so can damage the leaf collection vacuum and may cause costly delays. Leaves mixed with other yard waste will not be collected.

Please keep in mind that though collection staff abides by the schedule, there are certain circumstances that may delay leaf collection by one or more days. These circumstances include: delays due to weather, emergency situations that may draw staff away from their regular duties, or damage to collection equipment that would require repair or unscheduled service.

If you miss your scheduled collection days, leaves may also be taken to the Residential Recycling Center at 8000 128th Street. The center will be open through December 1, weather permitting. 

Camera Partnership



The Pleasant Prairie Police Department has an ongoing crime fighting partnership with Village residents. The initiative, known as the **Community Camera Partnership** enables residents to share video footage with the Police Department from home security cameras, aimed outdoors, if a crime or suspicious activity occurs in their neighborhood.

The department sees the partnership as a modern day extension of the Neighborhood Watch Program. They are planning to use this footage to solve crime in our community more efficiently, and to deter future crime from occurring.

Through a short questionnaire on the Village website, residents can log their home as a location where a camera may be able to provide assistance should a crime or suspicious activity occur. The locations will be marked on a map. If a crime is reported near one of the locations, officers would know that they could contact a resident in the area to ask them to look at their camera footage.

It is important to note that all aspects of this program are completely voluntary, and that at no time would the police have any remote access to the home security system. The home owner remains in complete control of their personal camera system.

Pleasant Prairie Historical Society Photography Collection


