Pleasant Prairie Launches Online Survey


to Update the 2023 Park and Open Space Plan

The primary purpose of updating the plan and surveying the community is proactively planning for the Village's future park and recreation needs. The policy recommendations and

The Village Park Commission encourages everyone to participate in the survey. New development in Pleasant Prairie has many positive impacts, including generating new tax revenue that supports critical community services.

The Community Development Department strives for sustainable Village growth and uses strategies to ensure a bright future for its residents and businesses. A stagnant community may face economic decline, limited job opportunities, and a lack of investment. While a thriving and growing community presents numerous benefits, including expanded economic opportunities, improved infrastructure, and enhanced services to create an environment that reflects the goals and values of the community.

HARIBO Facility Begins Production



HARIBO of America announced the commencement of Goldbears gummi candy production at the company's first-ever North American manufacturing factory in Pleasant Prairie. The 500,000-square-foot factory includes production areas, an administrative building, and a warehouse. HARIBO plans to expand the site further in the coming years with additional buildings.

The facility currently employs nearly 200 people, and the company aims to add hundreds more as expansions continue. HARIBO officials cited shared values of quality, trust, and independence, along with the area's work ethic and welcoming attitude, as reasons for choosing Pleasant Prairie for U.S. production.

There has been a lot of excitement and interest surrounding the candy factory development from area guests and residents. Many people on social media asked if the facility would offer tours or if a factory retail store would be available to the public. Village staff reached out to HARIBO and the company has yet to announce any public-facing elements. Village Administrator Eric Rindfleisch stated, "Good things take time, and we know that HARIBO will tell us when there's news to share."

The iconic Goldbears have been a favorite since their launch in 1960 and are now officially recognized as a registered trademark.

HARIBO candies have been imported into the United States since 1982, and the company expressed its long-term commitment to Pleasant Prairie, aiming to be part of the community for generations to come.

Village Administrator Receives ICMA Credentialed Manager Designation



Eric Rindfleisch, Village Administrator of Pleasant Prairie, Wisconsin, recently received the Credentialed Manager designation from ICMA, the International City/County Management Association. Rindfleisch is one of over 1,300 local government management professionals currently credentialed through the ICMA Voluntary Credentialing Program.

ICMA's mission is to advance professional local government through leadership, management, innovation, and ethics and by increasing the proficiency of appointed chief administrative officers, assistant administrators, and other employees who serve local governments and regional entities around the world. The organization's 13,000 members in 27 countries also include educators, students, and other local government employees.

To receive the prestigious ICMA credential, a member must have significant experience as a senior management executive in local government; have earned a degree, preferably in public administration or a related field; and demonstrated a commitment to high standards of integrity and lifelong learning and professional development.

"Eric's achievement of Credentialed Manager from ICMA shows his commitment to excellence in local government management," said Village Trustee Michael Pollocoff. "His dedication to professional development sets a great example for the staff, and we are proud to have him as the Village Administrator in Pleasant Prairie. His collaborative approach to local government management and vision for the community's future shows his commitment to achieving the highest quality standards for our municipality."

Rindfleisch is qualified with almost 13 years of professional local government executive experience. Before his appointment in 2022 as Village Administrator of Pleasant Prairie, he served as City Administrator in Onalaska, Village Administrator in McFarland and Edgar, and Director of Administration in Lodi, Wisconsin. Rindfleisch holds a Wisconsin Certified Public Manager designation from the University of Wisconsin – Madison and a master's degree in Public and Nonprofit Administration from Metropolitan State University, and previously served Sheboygan, Wisconsin, as Common Council President and Alderperson.

Proposed Shell Gasoline Facility



The Village of Pleasant Prairie is reviewing requests from a developer that intends to bring a new Shell Gasoline facility with a convenience store, car wash, and Dunkin' Donuts (Dunkin') to Pleasant Prairie. The development area is at the northeast corner of State Trunk Highway 32 (Sheridan Road) and 128th Street. Robert Stambolic has presented the proposal on behalf of Trevor RE LLC.

The development will remove the four structures on the properties to construct a Shell Gasoline facility with 16 fueling positions, a 4,020-square-foot convenience store with a Dunkin' drive-through, and an outdoor seating area. The project also plans to have a detached car wash facility spanning 2,200 square feet.

To safely maintain traffic flow in the area, the project will include adjustments to roadways and the installation of traffic signals at the intersection of Sheridan Road and 128th Street. Additionally, RS Fuels will make the necessary public enhancements on a segment of 128th Street to ensure the seamless execution of the project.

The site has the potential to generate new employment opportunities, creating 15 full-time and ten part-time positions, all of which will be operational across two shifts. The project's design includes provisions for electric vehicle parking spaces. There is also a commitment to maintaining ambient noise levels and to having site lighting that meets dark sky requirements. Construction is anticipated to begin in fall 2023 and be completed in spring of 2024. □



Café Zupas



Café Zupas proposes renovating and occupying the vacant drive-thru restaurant formerly home to Corner Bakery at 9250 76th Street in the Prairie Ridge development. The company is headquartered in Sandy, UT, has been operating since 2004, and owns 70 restaurants across multiple states. Café Zupas is growing and intends to have 78 company-owned restaurants by the end of 2023, including three in the Milwaukee and Madison markets.

Café Zupas is known for daily-made soups, salads, and sandwiches using fresh ingredients and chef-crafted recipes. Locations typically operate from 11:00 a.m. to 8:00 p.m., with extended weekend hours, and are closed on Sundays. The new Pleasant Prairie site intends to have 80 seats, employ up to 12 staff during peak periods, and have 40 new hires. The renovation plans intend to complement the existing shopping center while incorporating the Café Zupas brand identity. A detailed rendering is pictured above. \square


Tank of the Year Nomination

Highland Estates Zoning Amendments

Receive Village Board Approval


An updated Highland Estates Master Development Plan of approximately 275 acres between 93rd and 104th Streets. west of the existing Devonshire and Village Green Heights subdivisions, received Village Board approval for the requested Zoning Text Amendments. The support aligns with the favorable recommendations provided by the Plan Commission on August 7. It includes Zoning Map Amendments to rezone areas for the proposed development. The approval also creates three Planned Unit Development Ordinances for each residential area. single-family, two-family duplex, and two-unit condominiums.

Since the initial public hearing on May 1 and Village Board Master Conceptual Plan approval on May 8, the development team has worked diligently with Village staff to modify the proposed plans to address the concerns voiced by residents. A public informational progress meeting was held on August 7 at the Village Hall to communicate the changes made to the Master Conceptual Plan. During the meeting, the developer, Saniav Kuttemperoor of ZL River Development LLC, explained how community input was considered and how adjustments were made to better align with residents' expectations.

To address concerns surrounding the project density, the number of lots, initially proposed at 735, has scaled down to just over 700. Additionally, lot sizes and widths increased for many properties, along with road layout adjustments, to enhance the development's overall functionality and aesthetic appeal. Beyond housing plans, the revised plan includes nearly eight acres of zoned public park space to provide an expanded recreation and community gathering area. Additionally, the developer responded to citizen concerns about the proposed single-family rental units and has eliminated them from the project.

Traditionally, Southeast Wisconsin witnessed the establishment of one-third or half-acre lots: however, the changing economic landscape, characterized by construction costs, industry standards. and engineering expenses, is changing the size of new housing developments. The developer's adjusted plans intend to develop lot sizes that offer quality housing options that are anticipated to range from \$400,000 to \$650,000. The updated plans for Highland Estates has single-family lots ranging from 6,900 to 30,321 square feet, two-family lots from 8,624 square feet to 21.178 square feet, and about 40 two-unit condominiums on approximately 17.56 acres of land.

The proposed subdivision development has taken significant strides with the approval of the Master Conceptual Plan and Zoning Text Amendments. The Village Community Development Department will remain engaged in the planning process, collaborating with the developer over the upcoming six to eight months. during which essential stages such as Preliminary Plat and Final Plat for the first phase will be pursued. The project will develop in multiple phases spanning a decade. Initial construction is slated to commence at Cooper Road and 93rd Street's intersection, gradually expanding in a southwesterly direction.



LMI Packaging Expands

50,000 Sq. Ft. Facility Addition



On July 19, LMI Packaging held a groundbreaking ceremony for its 50,000-square-foot packaging facility expansion at 8911 102nd Street in LakeView Corporate Park. Third-generation owner and CEO J.P. Moran expressed his excitement about the development, emphasizing his "love" for Pleasant Prairie and the company's commitment to the state since relocating to Wisconsin in 1993.

LMI will primarily use the new expansion for internal warehouse space, which became necessary due to the company's significant growth. The company mainly manufactures heat-seal lids for the food and beverage markets, about 3.6 billion pieces annually. LMI Packaging has doubled its manufacturing machinery within the last year and a half. Owners anticipate it will happen again and expect to expand product lines at the facility within two years. This building expansion will add to the west side of the 70,955-square-foot LMI Packaging facility. The company will construct the nearly 50,000-square-foot addition with precast panels and paint that matches the existing facility. Construction crews anticipate completion by early December.

Moran thanked his workers for their efforts and acknowledged Pleasant Prairie Village Community Development Director Jean Werbie-Harris for her essential role in the expansion project.

"We are excited to see the growth of LMI Packaging and their continued investment in Pleasant Prairie," said Village Administrator Eric Rindfleisch. "The facility expansion will create additional job opportunities for the community and contribute to the overall economic development of Pleasant Prairie."



U.S. Vice President Kamala Harris Visit

Announces Nokia and Sanmina Partnership Bringing 200 New Jobs



On August 3, U.S. Vice President Kamala Harris, joined by U.S. Commerce Secretary Gina Raimondo and U.S. Senator Tammy Baldwin, visited the Sanmina Corporation, a local manufacturing company located at 8701 100th Street in Pleasant Prairie. The purpose of the visit was to emphasize the Biden Administration's commitment to revitalizing American manufacturing and to announce a partnership between Nokia and Sanmina that aims to bring jobs to the community.

During the visit, Vice President Harris highlighted the Biden

Administration's efforts to improve high-speed internet access, promote domestic manufacturing, and generate employment opportunities. Finnish telecom equipment leader Nokia revealed plans to produce broadband network electronics products within the U.S. under the Broadband Equity, Access, and Deployment (BEAD) program. This new production endeavor at Sanmina's Pleasant Prairie facility is expected to create up to 200 new jobs.

Nokia's choice to collaborate with Sanmina in manufacturing broadband electronics in the U.S. signifies a crucial moment. Commencing in 2024, Nokia will become the first telecom company to manufacture broadband electronics products in the United States domestically. This strategic move underscores the potential of both domestic and international collaborations in driving innovation and progress.

Vice President Harris acknowledged Senator Tammy Baldwin's role in advocating for projects that contribute to Wisconsin's economic growth. The event celebrated the alignment and collaboration among federal, state, and local entities, all working together to cultivate a thriving economic environment for Pleasant Prairie and beyond. \square

Visit the Residential Recycling Center at 8000 128th Street on September 16, from 9:00 a.m. to noon, for the Pleasant Prairie Shred Day Event. Dispose of unwanted documents safely and for free. Paper Tiger's specialized shredders will destroy your confidential papers and CDs on-site.

This service is **free of charge for residents**. Shredding old personal documents can help protect against fraud and identity theft. Plus, Paper Tiger recycles all shredded material, helping the environment. \Box

Fall Residential Leaf Collection

As a part of the Solid Waste Services provided in the Village, crews collect loose, unbagged leaves directly from your curb or roadside. Four rounds of leaf collection will take place this fall. Weather permitting, Fall Residential Leaf Collection will run between **October 2 and November 29**.

To have leaves collected, follow these steps:


- Identify your collection zone on the map at the right. Then see the schedule to determine your collection dates.
- To prepare leaves, rake all loose fallen leaves into a pile at the curb or roadside by 7:00 a.m. on the collection dates. Because leaves are collected with a vacuum, the leaves must be piled loose.
- Leaves must be within six feet of the road and kept off the asphalt.
- Residents with curbs and gutters, place loose leaves on the grass by your curb.
- Residents with a ditch line, place loose leaves on the grass along the roadside.
- Bagged leaves or grass, branches and other yard waste will not be collected.
- Do not mix other yard waste, such as potted/garden plants or branches, into your pile of leaves. Doing so can damage the leaf collection vacuum and may cause costly delays. Leaves mixed with yard waste will not be collected.

Please keep in mind that though collection staff abides by the schedule, there are certain circumstances that may delay leaf collection by one or more days. These circumstances include: delays due to weather, emergency situations that may draw staff away from their regular duties, or damage to collection equipment that would require repair or unscheduled service.

If you miss your scheduled collection days, leaves may also be taken to the Residential Recycling Center at 8000 128th Street. The center will be open for on-season hours through December 1, weather permitting. The Residential Recycling Center will remain open on Saturdays between 7:00 a.m. -3:00 p.m. throughout the off-season (December through March). Public Safety Teams Compete in Trike Competition



On July 20, first responders met for a thrilling competition at the Washington Park Velodrome. Local law enforcement officers and firefighters came together for the annual First Responders Night. The event at the historic velodrome in Kenosha at 1821 Washington Road held a heated competition among Kenosha County public safety personnel.

In this year's edition of the Battle of the Trikes, the age-old rivalry between fire and law enforcement personnel took center stage. With remarkable determination and sportsmanship, the participants raced lime green trikes. The competition unfolded through three exhilarating heats: one dedicated to the law enforcement teams, another featuring the fire departments, and a final round between the top performers from both groups.

A lineup of individuals for the law enforcement heat included Kenosha Police Chief Patrick Patton, Pleasant Prairie Chief David Smetana, Sergeant Colin Coultrip of the Sheriff's Department, and Twin Lakes Interim Chief Katie Hall. With a touch of humor, Chief Smetana revealed his aspiration to keep up with the competition, acknowledging the challenge of the race. Ultimately, Sgt. Coultrip emerged as the victor.

In the fire departments' heat, competitors such as Cade Kuebler of Kenosha Fire and EMS, Sergio Henby of Somers Fire and Rescue, Zach Keller of Pleasant Prairie Fire and Rescue, and Nick Keller of Bristol Fire and Rescue demonstrated exceptional sportsmanship. Zach Keller secured first place with the added thrill of competing against his brother, Nick. "I think it's just cool we got to do it together," Zach Keller said.

The final lap of the competition saw Zach Keller, Patton, Coultrip, and Kuebler compete for the title of 2023 Battle of the Trikes champion. The race was a neck-and-neck battle, but Zach Keller emerged as the ultimate victor. Expressing his delight, he humbly remarked, "I was just happy to be here and have fun."

RecPlex Indoor Water Park Maintenance and Wibit

The RecPlex indoor water park is undergoing essential maintenance beginning September 4 and continuing through September 15, 2023. The annual fall shutdown aligns with the facility's commitment to maintaining a safe, clean, and enjoyable environment. The maintenance concentrates on specific areas, including the whirlpool, warm water lap lanes, current channel, play structure, and purple slide.

The Aqua Arena, featuring an Olympic-sized swimming pool, will remain open throughout maintenance. RecPlex also maintains access to family changing rooms, locker rooms, and saunas. The Village Recreation Department is thrilled to announce that the Wibit, an inflatable water play structure, will be set up in the Aqua Arena and available for family swim hours during the maintenance shutdown. The Wibit offers an interactive and exciting aquatic feature with various obstacles, creating an entertaining activity for individuals and families.

Due to the varying water depths within the Aqua Arena, lifeguards will staff the Wibit during family swim. Anyone looking to use it will need to pass a short swim test without a life jacket. All participants must be at least six years old and are required to wear a life jacket. A few life jackets are available on a first-come-first-served basis; however, it is recommended that users bring their own.



While the indoor water park undergoes maintenance, all other facility amenities at RecPlex will remain fully operational, including the field house, indoor running track, ice arenas, fitness center, childcare services, sports programming, and therapeutic recreational programs.

Director of Recreation Programming Brett Christopher explained, "The water park provides a year-round indoor setting for young swimmer development, family swimming, birthday parties, and more. These annual improvements are a strategic investment aimed at extending the longevity of the popular asset."

The annual closure maintains the water park's quality standards by cleaning and conducting refurbishments that help extend the life of the water park, providing a fun experience to members, families, and guests. Village Recreation staff anticipates the refreshed water park will reopen on September 16. \square

Reminder to Maintain Right of Way

The Village of Pleasant Prairie is reminding residents, including those with new sidewalks in recently constructed areas, about the importance of maintaining the right of way within the community. The right of way is the publicly owned space between private properties and the road, encompassing sidewalks, areas by the curb, and adjacent strips of land. Residents are responsible for several tasks to uphold the right of way:

- **Trimming Trees:** Property owners should ensure that trees and branches from their property don't obstruct the right of way, especially overhanging branches that could interfere with pedestrians, cyclists, or vehicles.
- **Cutting Grass:** Regular upkeep of grassy areas within the right of way is essential for appearance and functionality. Property owners need to mow the grass, remove weeds, and maintain the tidiness of the area.
- **Shoveling Sidewalks:** During winter, residents must promptly clear snow and ice from the sidewalks bordering their properties within the right of way. This guarantees safety and accessibility for pedestrians, including those with mobility challenges.





Maintaining the right of way benefits the community by improving aesthetics, safety, and quality of life. It also fosters a sense of pride and shared responsibility among neighbors, enhancing the overall community atmosphere.

Historical Society Pleasant Prairie's First Fire Engine



In March of 1935, a local tragedy motivated the Pleasant Prairie community to form their own Fire Department. When the Town Board received the petition signed by 502 residents, they immediately ordered a 1935 Peter Pirsch Model 21 fire engine. By August 22, 1935, the Pleasant Prairie Fire Department was officially operational.

That first fire engine was in service in Pleasant Prairie until 1961, when it was sold to Fire Department member James Harman. In 2008, the fire engine was owned by the Paris Fire Department, when it was re-purchased by the Pleasant Prairie Fire & Rescue Association charity organization. Through several fundraising efforts, the Association raised \$28,457 for the fire engine's restoration.

Before dissolving in 2021, the Association donated the fire engine and restoration funds to the Pleasant Prairie Historical Society. The Historical Society agreed to continue efforts to restore the fire engine to its original working condition. The Historical Society has since raised an additional nearly \$5,000 for the restoration, bringing the total raised funds over halfway to the estimated \$65,000 needed to restore the fire engine.
