Village Names PPCVB Executive Director

On Monday, October 1, the Pleasant Prairie Village Board named Michelle Williamson as Executive Director of the Pleasant Prairie Convention and Visitors Bureau (PPCVB). The Village initiated the effort to establish the PPCVB in January 2018 to focus on promoting Pleasant Prairie as a tourism destination.

As Executive Director, Williamson will ensure the growth of the PPCVB and the Village's travel and tourism related businesses. She will lead a comprehensive marketing and public relations program for Pleasant Prairie to promote tourism, encourage overnight stays, and highlight the Village's sporting venues, shopping, and other attractions.

Williamson comes to the PPCVB from Carthage College where she spent 19 years in the Office of Admissions. As Director of Admissions and Financial Aid, she guided thousands of students and

families throughout their college search process. In addition, Williamson played an integral role in admissions events and marketing. She planned and coordinated major annual scholarship events and site visit programs.

"I am very excited to bring my expertise in event planning, marketing, and promotions to the Pleasant Prairie Convention and Visitors Bureau," commented Michelle Williamson, "I look forward to sharing all of our community's incredible attributes with the region and beyond."

Lake Michigan Water Diversion

Recently the Village of Pleasant Prairie has been under some scrutiny resulting from the promotion of Peter Annin's recently re-released book, "The Great Lake Wars."

In the late 1980's, when Pleasant Prairie began to evaluate water provision throughout the municipality it was discovered that the underground water system was contaminated with radium. The Village sought approval to use Lake Michigan as the Village's water source. Half of the Village is in the Lake Michigan water basin and the other half is in the Mississippi River water basin, which required the Village to approach the Great Lakes Governor's Council for water diversion. Under the Water Resources Development Act, the Village was approved to draw 3.2 million gallons of water per day from Lake Michigan through the Kenosha Water Utility.

This agreement was conditional on the Village decommissioning water treatment plants in the Mississippi River basin and directing all waste water to be recycled and returned to Lake Michigan through the Kenosha Water Utility by 2010. The Village complied with this condition, and currently operates a closed system, meaning that technically little to no water is truly diverted because it is returned to the Great Lakes basin via the Kenosha Treatment facility.

In 2008 the Great Lakes Compact became the new governing law for water diversion. To comply with the new legislation the Department of Natural Resources (DNR) worked to establish a uniform criteria for diversion volumes of all grandfathered communities including Pleasant Prairie. In 2010 the DNR formally issued the revised diversion number to all grandfathered communities based on the 2007 projected population, land

use within the approved sewer service area, and to reflect the State's requirement of municipalities to build infrastructure to meet future capacity and demand. Pleasant Prairie's revised grandfathered volume became 10.69 million gallons per day reflecting anticipated growth in the area estimated by the regional planning commission.

"It's doesn't make sense to oversize infrastructure, but then restrict the supply on the actual water we can provide in that system," stated Village Administrator, Nathan Thiel.

In granting the increase the State complied with the laws. The Village has been compared to more recent diversion requests like Waukesha and Foxconn; however, it is important to remember the Village's:

- Original permit and conditions predates these developments by several decades,
- Territory straddles the Mississippi River and Great Lakes divide, and
- System is closed and all wastewater is recycled and returned back into Lake Michigan.

Today, the Village's average water use is 2.7 million gallons per day and peak usage is 5.7 million gallons per day. As more businesses develop and neighborhoods expand in Pleasant Prairie, more water will be used.

"The Village believes in water conservation and prides itself on smart and sustainable growth," said Thiel, "It is unfortunate that the definition of diversion is being unfairly misapplied on the Village given our balanced approach."

Dark Store Loophole Videos

As big box retail chains and single tenant commercial properties use dark store tax avoidance strategies to significantly reduce their property taxes, other taxpayers, mainly homeowners, will see their property taxes increase as they shoulder more of the tax levy. National big box



retail chains and other commercial property owners are challenging their assessed values using the "Dark Store Strategy" to argue that their thriving business locations must be assessed for tax purposes as though they were a vacant, abandoned property. Learn more at www.lwm-info.org. □

Advocate Aurora Health Care Groundbreaking

On Tuesday, October 9, Advocate Aurora Health Care groundbreaking took place at Prairie Highlands Corporate Park (located along West Frontage Road and STH 165).

The facility will include a 100,000-square-foot ambulatory care center and 100,000-square-foot professional office building. It is expected to open in the summer of 2020. The new facility will employ 260 full-time and 28 part-time employees.

The health care center will offer general surgery, orthopedics and urology along with new pediatric specialty services for Aurora Children's Health. The center also will have a pharmacy, laboratory and rehabilitation areas.

"As our community grows so does the need for healthcare," said Village President, John Steinbrink, "We are proud to offer our residents some of the most affordable and highest quality healthcare centers in Wisconsin." □

Recycling Tips

Reduce the amount of trash placed in landfills

The Village would like to thank the many households who consistently sort recycled materials out of their garbage stream. Your help truly makes a difference in the amount that our community pays towards landfill costs and on the impact that our trash has on the environment. The Village would like to encourage more households to do the same.

In order to make recycling as easy as possible the Village would like to remind residents of how to recycle certain items, whether it be curbside or at the Residential Recycling Center.

Curbside Recycling

Rinse/wash and recycle the following items in your blue covered recycling cart:

- clear plastic containers, bottles and lids **marked with numbers 1-7**
- glass bottles, jars, and containers
- aluminum or steel (tin) cans

Please recycle the following paper items in your blue covered recycling cart:

- cardboard, newspapers, and magazines
- catalogs, flyers, and junk mail
- boxboard (unlined merchandise boxes)
- telephone books and paperback books
- typing, copy and printer paper
- stationery, envelopes, and bills
- brown paper bags

Please call the Village at 262.925.6700 for a second recycling cart. There is no additional fee for a second recycling cart.

Residential Recycling Center

Pleasant Prairie Historical Society Green Stamps

When cleaning out the closet, a recent artifact donated to the Society brought back an Americana memory. The year was 1965. After weeks or even months of collecting those little green stamps at supermarkets, department stores, and gas stations, your S & H Green Stamps Saver Book was finally full! You flip through the pages of your booklet filled with 1,200 little green stamps as you contemplate what gift in the S & H Ideabook that you will trade them in for. There was always something for every room of your house. The possibilities of those little green stamps seemed endless: dishes, linens, appliances, clock radio, sporting equipment, furniture, a television or any of a multitude of gifts for the family and the home.

Do you remember collecting S & H Green Stamps? If you did, you can probably relate to this feeling of excitement in deciding how best to spend your stamps. The popularity of S & H Green Stamps gained traction in the 1930s and peaked in the 1960s, but Sperry & Hutchinson Co. (S & H) was actually founded in 1896. And the company still exists today, and although it is completely online, you can still redeem your Green Stamps! The S & H Co. reward program became popular nationwide to reward shoppers based upon their spending. It is estimated that 80 percent of American households, including Pleasant Prairie residents, collected the Green Stamps during their heyday. The stamps were given with purchases to shoppers who would stick them into booklets and they were then redeemed through the S & H catalog or at redemption centers.
