Village Green Center Phase Two

On October 7, the Pleasant Prairie Village Board considered and approved an award of contract for Master Planning and Master Developer services to RINKA for the proposed Village Green Center mixed-use development of approximately 180 acres generally located at Springbrook Road and HWY 165.

As Phase One, earlier this year, the citizen engagement Community Collaboration committee, known as Designing Downtown Pleasant Prairie, worked together for seven months, volunteering more than 1,500 hours, to create a wide variety of development recommendations for the Village Green Center, a new downtown destination development.

This group of dedicated volunteers identified opportunities, researched ideas, and developed concepts for housing options, commercial district, park and recreation amenities, and public and civic facilities. Other areas of focus included environment friendly solutions, project marketing, and

the downtown's aesthetics, character, branding and themes.

The Village chose to use a new engagement process designed to let the community drive all aspects of the project's concept development allowing interested citizens to directly influence ongoing Village Green Center development activities undertaken by the Village.

Phase Two of the Village Green Center planning process involved the Village soliciting statements of qualifications from development professionals to lead in the Master Planning and Master Developer roles in the planning and development of the Village Green Center site. Village staff and members of Designing Downtown Pleasant Prairie steering committee interviewed master developer applicants and recommended that the Village Board offer the contract to RINKA.

For the next several months, Village staff, along with the Designing Downtown

Pleasant Prairie steering committee and RINKA, will work together to summarize and confirm the Designing Downtown Pleasant Prairie visions and goals. Based on those visions and goals, RINKA will develop a Concept Draft Master Plan and Civil Site Analysis, which will be presented to the public in an open house.

Upon approval of the Concept Draft Master Plan, RINKA, Village staff, and the Designing Downtown Pleasant Prairie steering committee will create a Final Village Green Master Plan and a Planned Development zoning document that will guide the layout and development of public and private improvements within the Village Green Center.



Progress in the Prairie: Prairie Highland Corporate Park



In early October, the Village completed Prairie Highland Corporate Park infrastructure improvements (roadways, storm sewers, sanitary sewers, water, grading, and storm water management) and grading operations. Operations began June of 2016 and took approximately 16 months to complete.

There are currently three businesses in the park: HARIBO of America, Advocate Aurora Heath Care, and Nexus Pharmaceuticals. Phase 1 of HARIBO includes production, warehouse, distribution buildings, a multi-story parking

structure, construction is planned to start late spring of 2020. Advocate Aurora anticipates to be open summer of 2020. Nexus construction is to begin this year and is expected to be completed in 2022.


There are potentially six remaining lots totaling 124 acres of land for future development. The Village is encouraged to see the significant interest of potential developers and industry for these remaining sites. \Box

Main Street Market Master Conceptual Plan

On Monday, September 16, the Pleasant Prairie Village Board considered and approved an updated Master Conceptual Plan and Certified Survey Map for the continued development of Main Street Market generally located at the northeast corner of STH 31 (Green Bay Road) and STH 165 (104th Street) and is being developed by Main Street Development LLC (Bear Development).

The property is subdivided into of six lots. The property is proposed to include office, gas station/carwash/c-store and multi-tenant commercial buildings. Froedtert South medical office building is the first tenant of Main Street Market which recently completed construction. Lot 1 is 2.22 acres and the future Kwik Trip gas station, car wash, and convenience store site. Lot 3 is .84 acres, Lot 4 is 1.68 acres, Lot 5 is 6.47, and Lot 6 is 3.04 acres.

An east/west public roadway is proposed to extend between STH 31 and Old Green Bay Road. Four private development driveways are proposed to connect to Old Green Bay Road. Plans for the widening of Green Bay Road and STH 165 and the STH 165/Old Green Bay Road intersection and Main Street have been provided to the Village and WIS DOT for final review, approval, and right-of-way land acquisition for the Old Green Bay Road widening. The acquisition of additional right-of-way from adjacent landowners on the south side of STH 165 has been completed by the developer.



Old Green Bay Road will be re-constructed with an urban cross section with curb, gutter, and public sidewalks/pedestrian ways. A new signalized intersection will be constructed at Old Green Bay Road and STH 165. A second new signalized intersection is proposed at STH 31 and future Main Street. Roadway cross section requirements have been defined which include bicycle and pedestrian accommodations.

It is anticipated that the work on STH 165 and Old Green Bay Road including the intersection will be started in late spring of 2020.

2020 General Government Budget

On Monday, October 21, Village staff presented the proposed 2020 general government budget to the Village Board. The budget proposes to increase the tax levy from \$12,306,203 in 2019 to \$12,652,261 for 2020, an increase of \$346,058. However, because of growth and development, tax bills should see little to no impact from the Village levy increase. For a average home in the Village valued at \$237,200, this will actually translate to a \$0.41 decrease in the Village portion of the property tax bill.

In 2020, the Village will receive about \$1,014 of the total property tax payment for the median-valued home. The funds will be used to cover Village services such as fire and rescue, police, community development, road improvements, and snow plowing. The proposed 2020 budget includes the addition of two full-time fire-medic positions, funding to increase part-time staffing in fire and rescue, two part-time Village employees, and replacement of emerald ash borer infected street trees. Proposed capital purchases include \$1.8 million for road improvements, the addition of one ambulance, one firetruck, replacement of seven police vehicles, and \$75,724 to replace mobile radios for fire and rescue.

A public hearing related to the 2020 budget is planned for Monday, November 18, at 6:00 p.m. The hearing will be held in the auditorium on the south side of Pleasant Prairie Village Hall, 9915 39th Avenue.

Sherwin-Williams Master Conceptual Plan

The Village Plan Commission considered and approved a Master Conceptual Plan on Monday, October 14, for the construction of a Sherwin-Williams store. The request was made by Kevin Vernick on behalf of MEV PP, LLC for a 4,000 square foot Sherwin-Williams store to be constructed on a 1.27 acre lot within the Prairie Ridge development generally located between 76th Street and Prairie Ridge Boulevard, east of 91st Avenue.

The Sherwin-Williams Company is an American Fortune 500 company in the general building materials industry. The company primarily engages in the manufacturing, distribution, and sale of paints, coatings, and related products to professional, industrial, commercial, and retail customers in North and South America and Europe. The company headquarters is located in Cleveland, Ohio. The Pleasant Prairie Sherwin-Williams store is intended to sell Sherwin-Williams branded architectural paints, coatings, industrial and marine products, equipment manufacturer product finishes, provide contractor support, sprayer maintenance and repair, and RRP Certification sessions & supplies.

The store hours will be Monday through Friday 7:00 a.m. to 8:00 p.m., Saturday 8:00 a.m. to 6:00 p.m., and Sunday 10:00 a.m. to 6:00 p.m. The store is projected to be under construction in February 2020 and completed and operational in June 2020.

2020 Solid Waste Utility Budget



What Is the Solid Waste Utility

The Solid Waste Utility provides curbside garbage, recycling, and leaf collection for approximately 7,540 homes. The utility also operates the Residential Recycling Center (RRC). It offers hazardous waste collection the first Saturday of each month, free compost and mulch, shred events, and Christmas tree drop-off sites.

What to Expect During 2020

As part of the 2020 Solid Waste Budget, the Village proposed to add a collection rate for residents that request pickup for brush and branches at their home. The RRC will continue to accept the same items. A few changes for 2020 are as follows: the cost for electronics recycling will increase to cover the cost to dispose of those items. Unlimited volumes of recycling and household hazardous waste can still be dropped off at no additional charge.

2020 Clean Water Utility Budget



What is the Clean Water Utility

The Clean Water Utility, operating since 2006, was created to protect lakes, streams, rivers, and groundwater from contaminated storm water runoff. Federal mandates require municipalities to improve storm water quality. Storm water comes from rain or melting snow which collects contaminants and transports them through the storm sewer and into our waterways. The Public Works department works to reduce these items

and keep our waterways clean.

Maintenance and replacement of existing storm water infrastructure are funded by the Clean Water Utility. New storm water projects that improve drainage in a specific drainage area are funded by affected property owners. The Village collects a storm water fee from property owners based on how a property generates storm water runoff. All properties contribute to storm water runoff to varying degrees based on soil type, surface, and property use. Funds collected are used to pay for: maintenance of Village-owned storm water infrastructure, maintaining catch basins, and preserving natural

drainage systems like streams and buffers. Infrastructure maintained by the Clean Water Utility is valued at more than \$23.2 million dollars. The Clean Water Utility does not hold any debt.

What to Expect During 2020

The Clean Water Utility will continue to perform street sweeping, outfall inspections, and catch basin cleaning. Planned projects for 2020 include shoreline protection along Lake Michigan, paving program clean water adjustments, asset repair of clean water infrastructure, Greenway Court culvert replacement. The Village is giving consideration to two new infrastructure storm water improvement projects in 2020 in Beverly Woods and in Chateau Eau Plaines. No Equivalent Runoff Unit (ERU) increases are proposed for 2020.

2020 Fleet Budget



The Fleet Internal Service Fund purchases, manages, maintains and repairs; vehicles, equipment, attachments, and tools for Village departments (except for Police and Fire & Rescue) through a pay-per-use system. Maintenance and replacement costs are factored in for each participating Village department. This system allows the Village to avoid borrowing. The fund manages all of the vehicles and equipment used to provide services to the residents of Pleasant Prairie.

The Fleet Internal Service Fund has accrued a replacement fund to purchase vehicle replacements. The fund also helps the Village track the cost of maintaining the fleet. A majority of equipment and vehicle maintenance is performed in-house by four full-time mechanics.

During 2020, the Fleet Internal Service Fund plans to replace a RecPlex van, pickup truck, sanitation truck, and out-of-service fleet vehicles; along with adding a leaf collector and building a plow truck with used cab and chassis totaling \$608,000 in vehicles and equipment. □

Fire & Rescue Department

Review and Assessment

The Village of Pleasant Prairie contracted McGrath Consulting Group, Inc. to conduct an audit of the Pleasant Prairie Fire & Rescue Department. The audit included current operations, staffing, and fiscal resources of the Fire & Rescue Department. McGrath Consulting presented their report during the Village Board meeting on Monday, October 7.

McGrath Consulting highlighted that the Pleasant Prairie Fire & Rescue Department is a well-run, highly trained, organized department. The Fire Department has strived to keep up with the growth of the community. The consultants made recommendations for a new fire station, staffing measures, and fire apparatus replacements for the Village of Pleasant Prairie Fire & Rescue Department.

The Pleasant Prairie Fire & Rescue Department operates out of two fire stations. Station #1 (located at 3801 Springbrook Road) was built in 2015 and contains all the latest technology for a fire station. It is currently staffed with three personnel assigned 24 hours a day. One of the two Assistant Chiefs offices is located at Station #1. Station #2 (located at 8044 88th Avenue) was built in 1994 and serves as the headquarters for the Department. It was not originally built to house full-time personnel and modifications were made in 1999 to accommodate the full-time staff although space is still limited. Station #2 has a minimum of three and up to six personnel assigned 24 hours a day.

In making the determination of what adequate staffing, the consultants analyzed the workload, which includes incident totals, training, apparatus maintenance, public education assignments, pre-planning, fire inspections and other scheduled activities, and the community risk profile. It is rare that fire departments have staffing that exceeds their needs. The consultants recommended increasing the minimum staffing at Station #1 and #2 from three to five for the benefit of the community and the fire department personnel. They also proposed a third station with three personnel. Station #3 would be considered a "jump company" where the crew would respond in an ambulance or engine based on the incident needs. A third fire station has been considered for the Village for many years. The consultant mentioned that additional staffing could be addressed through full-time, part-time hires, and potential contracted services.

The consultants stated that the Pleasant Prairie Fire & Rescue Department apparatus overall is in good shape. All the Department's Advanced Life Support (Paramedic) ambulances are state-of-the-art and contain all the necessary lifesaving



equipment. The Department recently replaced an aged aerial fire truck with a new ladder/tower in 2017.

A report from the Department shows that 90% of the community is fully supplied with fire hydrants. Because the Village has adequate water supply with fire hydrants, future vehicle replacements will not need to contain the large oversized chassis. This will allow for vehicles that have greater maneuverability and will be more versatile to the response needs of the community. Currently, Station #1 has three pumper/tenders that are aged and will need future replacement. The consultants recommended the purchase of both an aerial ladder "Quint" for Station #1 in addition to a Rescue Pumper. The Rescue Pumper is a type of fire vehicle that carries specialized rescue equipment and still functions as an engine/pumper.

Pleasant Prairie is well balanced with residential, commercial, and industrial property. There are inherent dangers associated with each of these types of structures. Due to these inherent dangers, Fire Chief Craig Roepke requires all members to be fully trained to handle any type of emergency that may occur within the community. All career personnel are certified in fire suppression, driving, pumping, and aerial operations of fire apparatus, hazardous materials, surface water/ice rescue, technical rescue, operations disciplines including: rope high/low access, confined space, trench, and structural collapse, confined space operations, and certified/licensed as paramedics.

The consultants commended Pleasant Prairie's Fire and Rescue Department fire and emergency medical services education and training surpasses all the surrounding communities' requirements. Dr. Benjamin Feinzimer, the Project Medical Director, which all department paramedics operate under, highly applauds the Department's aggressive approach to paramedicine training.

Keep It Loose

A recent change was made by recycling collection facilities. Starting in October 2019, recycling collectors no longer accept bagged recyclables. Recycling facilities consider recyclables that are held in plastic bags, such as aluminum cans in a plastic bag, as contaminated. Bagged recycling will be routed to in the landfill. Recyclables in paper bags are still accepted.

In the past, recycling facilities allowed a percentage of bagged recycling but now they reduced the percentage tolerated to zero. Pleasant Prairie Public Works collects 2200 tons of recycling every year. Currently about 16% (352 tons) of that recycling is in plastic bags, which would be routed to the landfill. It costs the Village \$150 per ton of bagged recyclables to be dumped in the landfill.

The community is doing a good job keeping recyclables loose in their carts but we need to increase this effort to not only help the environment but also bring collection costs down. You can help keep costs down and help the environment. Please keep your recyclables loose in the blue cart.

Public Works offers a second recycling cart to residents free of cost to encourage recycling.







Kwik Trip Donations

On September 18, the Village of Pleasant Prairie welcomed its fourth Kwik Trip to the community located 10215 120th Avenue (near I-94). Kwik Trip made two donations towards the community.

The first donation was for the Therapeutic Recreation program at RecPlex (pictured top right). Therapeutic Recreation is a special needs care program for youth and adults with disabilities.

The second donation was for the Pleasant Prairie Police K9 Unit (pictured bottom right). K9 Unit Chase recently started working in the community in the beginning of the summer and works with his handler, Officer Algiers.

Winter Weather Snow Safety



When snow starts to fall, the Public Works Department activates its **Snow and Ice Removal Plan.** Exactly what happens under the plan depends on the amount of precipitation that has fallen, is predicted to fall, the temperature, duration of the storm, and moisture content.

Remove your vehicles from public streets when approximately **2 inches** of snow has fallen or is predicted to fall. Vehicles parked in the road not only make it more difficult to clean the streets, but it also endangers safety by forcing drivers to zigzag in and out of traffic on slippery roads. As a reminder, the Village will ticket violators.

Snow emergencies are announced on Time Warner Cable Channel 25, at *PleasantPrairieWi.gov*, by text or email through **Nixle.com**, via Twitter and Facebook, and through local television, radio, and print media.

There are also steps you, as a resident, can take to ensure that snow removal operations run safely and smoothly:

- Please avoid driving or parking on the road during heavy snowstorms.
 Our primary purpose is to clear streets for emergency vehicles. If you must be out, please use extreme caution and do not drive too fast for conditions, wear a seat belt, drive sober, and avoid distractions.
- 2. Use caution when you encounter a snowplow. State law requires that you stay at least 200 feet behind a working snowplow. When following a snowplow, make sure that you can see the driver's mirrors so the driver is able to see you.
- 3. **Do not shovel or blow snow into public streets.** This not only defeats the purpose of our snow plowing, but it is a violation of Village Ordinances because it causes unsafe conditions for all drivers. All shoveled or blown snow must be piled in your yard or parkway.
- 4. If you live in a portion of the Village where sidewalks have been installed, please remove snow and ice from your sidewalk within 24 hours of a snowfall. Clear snow and ice away from fire hydrants located on or near your property. Keeping hydrants clear will help save valuable time, should a fire emergency occur in your neighborhood.
- 5. The Village encourages all residents to please **assist your elderly neighbors** with snow removal tasks whenever possible.


